## TRUSTEE'S DEED

THIS INDENTURE made this 31<sup>st</sup> day of March, 1977, between AMERICAN NATIONAL BANK AND TRUST COMPANY OF CHICAGO, a corporation duly organized and existing as a national banking association under the laws of the United States of America, and duly authorized to accept and execute trusts within the State of Illinois, not personally but as Trustee under the provisions of a deed or deeds in trust duly recorded and delivered to said national banking association in pursuance of a certain Trust Agreement, dated the 11<sup>th</sup> day of April, 1974, and known as Trust Number 32728, party of the first part, and ARTHUR P. WITNESSETH, that said party of the first part, in consideration of the sum of ---\$10.00--- Ten Dollars and no/100--- Dollars, and other good and valuable considerations in hand paid, does hereby grant, sell and convey unto said parties of the second part, not in tenancy in common, but in joint tenancy, the following described real estate, situated in Cook County, Illinois, to-wit:

Lot 10 in Block 4 in Tenth Brothers and Company's Second Bellevue Addition to Roseland in the Southwest Quarter of Section 16, Township 37 North, Range 14, East of the Third Principal Meridian, in Cook County, Illinois.

together with the fixtures and appurtenances thereto belonging.  
TO HAVE AND TO HOLD the same unto said parties of the second part, forever, not in tenancy in common, but in joint tenancy.

This deed is executed by the party of the first part, as Trustee, as aforesaid, pursuant to and in the exercise of the power and authority granted to and vested in it by the terms of said Deed or Deeds in Trust and the provisions of said Trust Agreement above mentioned, and of every other power and authority therunto belonging. This deed is made subject to the laws of said trust deeds and/or mortgages upon said title estate, if any, recorded or registered in said county.
