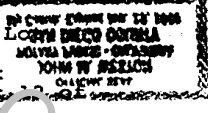

2. Ordinances, restrictions, covenants and easements.

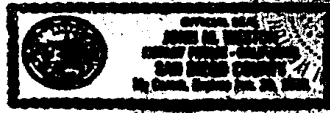

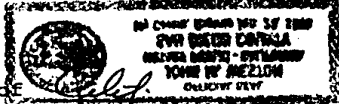
