THIS INDENTURE WITNESSETH, That the Grantor, MARION KANE, a widow and
not remarried,

of the County of Cook and State of Illinois for and in consideration
of TEN and No/100ths Dollars, and other good
and valuable considerations in hand paid, Conveys and Quit Claims unto the
FIRST BANK OF OAK PARK, an Illinois Corporation, its successor or
successors, as Trustee under the provisions of a trust agreement dated the 1st day of

TO HAVE AND TO HOLD the said premises and all appurtenances upon the trusts and for the uses and purposes herein and in said trust agreement set forth.

In no case shall any party dealing with said trustee in relation to said premises or to whom said premises or any part thereof shall be assigned, contracted to be sold, leased or mortgaged by said trustee, be obliged to give to the applicant of any such money, rent or income received by advanced notice of at least one month prior to the date of sale, lease or mortgage, or to whom said premises or any part thereof shall be given to the beneficiary or payee of any act of said trustee, to be obliged or privileged to inquire into any of the terms of said trust agreement, and every deed, trust deed, mortgage, lease or other instrument executed by said trustee in relation to said real estate shall be conclusive even though the same may be created in trust and notwithstanding that such conveyance or other instrument was executed in accordance with the conditions and restrictions contained in this indenture and as an instrument of this indenture, such amendment thereto and updating all the beneficiaries thereunder, let it be known, that said trustee is duly authorized and empowered to execute and deliver every such deed, trust deed, lease, mortgage or other instrument and (d) that if the conveyance is made to a successor or successors in trust, that such successor or successors in trust have been properly appointed and are fully vested with all the title, estate, rights, powers, authorities



statutes of the State of Illinois, providing for the exemption of homesteads from sale on execution or otherwise.
