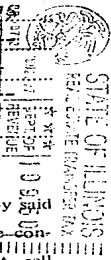
This Indenture made this 17th day of May A. D. 19 77, by and between First National Bank of Evergreen Park

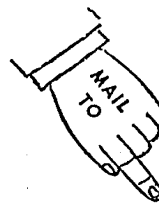
