THIS INDENTURE, made **May 12, 1977**, between **Frederick C. Niemi** and **Valerie S. Niemi**, his wife of the Village of Winnetka, County of Cook, State of Illinois.

herein referred to as "Mortgagors," and
THE WINNETKA BANK,

an Illinois corporation doing business in Winnetka, Illinois, herein referred to as TRUSTEE, witnesseth:

THAT, WHEREAS, the Mortgagors are justly indebted to the legal holder or holders of the instalment Note hereinafter described, said legal holder or holders being herein referred to as Holders of the Note, in the principal sum of **Forty Thousand and 00/100 (\$40,000.00)** Dollars, evidenced by one certain instalment Note of the Mortgagors of even date herewith, made payable to THE WINNETKA BANK and delivered, in and by which said Note the Mortgagors promise to pay the said principal sum and interest from **June 15, 1977** on the balance of principal remaining from time to time unpaid at the rate specified in said note, and in instalments as follows: **Three hundred nine and 91/100 (309.91)**

Dollars on the **10** day of **July** **1977** and **Three hundred nine and 91/100 (309.91)**

Dollars on the **10** day of each month thereafter until said note is fully paid except that the final payment of principal and interest, if not sooner paid, shall be due on the **10** day of **June** **2006**

All such payments on account of the indebtedness evidenced by said note to be first applied to interest on the unpaid principal balance and the remainder to principal; provided, that the principal of each instalment unless paid when due shall bear interest at the rate of **9** per cent per annum, and all of said principal and interest being made payable at such banking house or trust company in Cook County, Illinois, as the holders of the note may, from time to time, in writing appoint, and in absence of such appointment, then at the office of THE WINNETKA BANK in the Village of Winnetka, Cook County, Illinois.

NOW, THEREFORE, the Mortgagors to secure the payment of the said principal sum of money and said interest, in accordance with the terms, provisions and limitations of this trust deed, and the performance of the covenants and agreements herein contained, by the Mortgagors to be performed, and also in consideration of the sum of One Dollar in hand paid, the receipt whereof is hereby acknowledged, do by these presents CONVEY and WARRANT unto the Trustee its successors and assigns, the following described Real Estate and all of their estates, right, title and interest therein, situated lying and being in the **Village of Winnetka** COUNTY OF **Cook** AND STATE OF **ILLINOIS**,

Lot 19 in Block 9 in Groveland Addition to Winnetka, being a Subdivision of the east 70 acres of the north west 1/4 of Section 20, Township 42 north, Range 13 east of the Third Principal Meridian, in Cook County, Illinois

which, with the property hereinafter described, is referred to herein as the "premises."

TOGETHER with all improvements, tenements, fixtures, appurtenances thereto belonging, and all rents, issues and profits thereof for so long and during all and times as the Mortgagors may be the owners thereof, including all fixtures, furniture, equipment, and articles now or hereafter thereon used to supply heat, gas, air conditioning, water, light, power, refrigeration (whether single units or centrally controlled), and ventilation, including (without restricting the foregoing), screens, window shades, storm doors and windows, floor coverings, indoor beds, awnings, covers and water tanks, and all similar apparatus, equipment or articles heretofore placed in the premises by the mortgagors or their successors or assigns shall be considered as constituting part of the real estate.

TO HAVE AND TO HOLD the premises unto the said Trustee, its successors and assigns, forever, for the purposes and upon the uses and trusts herein set forth, free from all rights and benefits under and by virtue of the Homestead Exemption Laws of the State of Illinois, which said rights and benefits the Mortgagors do hereby expressly release and waive.

This trust deed consists of two pages. The covenants, conditions and provisions appearing on page 2 (the reverse side of this trust deed) are incorporated herein by reference and are a part hereof and shall be binding on the mortgagors, their heirs, successors and assigns.
