THE AGREEMENTS, CONDITIONS AND PROVISIONS REFERRED TO ON THE REVERSE HEREOF.

1. Mortgagor agrees to pay each item of indebtedness secured hereby, when due, according to the terms hereof.

2. Mortgagor agrees,

(a) to keep the premises in good repair and make all necessary replacements;

(b) to restore or rebuild promptly any building or improvement now or hearefler on the premises which may become damaged or destroyed;

(c) to comply with all laws and municipal ordinances with respect to the premises and their use;

(d) to keep the premises free from liens of mechanics and materialmen, and from all other liens, charges, or encumbrances prior to or on a parity with the lien of this Trust Deed;

(e) to permit the Trustee or holder(s) of the Note access to the premises at all reasonable times for purposes of inspection;

(f) not to do, nor permit to be done upon the premises, anything that might impair the value thereof, or the security conveyed hereby.

Mortgagor further agrees that no substantial repairs or remodeling of the premises shall be made unless the written consent of the runtee or the holder(s) of the Note shall first have been obtained and Mortgagor shall have deposited with Trustee as sum of money ufficient in the judgement of Trustee or the holder(s) of the noney so deposited either during the progress of such repairs or remodeling. Trustee is heavy authorized to apply the money so deposited either during the progress of such repairs or remodeling, or upon completion thereof, in properties to pay promptly, and before any penalty attaches, all water rates, sewer charges. general and social trustees assess mens of any kind which may be levied, assessed charged and social trustees.
