RIDER ATTACHED TO AND MADE PART OF TRUSTEE'S DEED DATED May 27, 1977 FROM AMERICAN NATIONAL BANK AND TRUST COMPANY OF CHICAGO, A NATIONAL BANKING ASSOCIATION, AS TRUSTEE UNDER TRUST AGREEMENT DATED OCTOBER 24, 1975, AND KNOWN AS TRUST NO. 38035, GRANTOR, TO

Unit 317-3 in the Flagg Creek Condominium as delineated on survey of part of the North West 1/4 of Section 29, Township 38 North, Range 12 East of the Third Principal Meridian, in Cook County, Illinois (hereinafter referred to as Parcel), which survey is attached as exhibit "A" to declaration of Condominium made by American National Bank and Trust Company of Chicago, Trus' Number 38035 recorded in the Office of the Recorder of Deeds of Cook County, Illinois as document #23676217 as amended from time to time; together with its undivided percentage of interest in said parcel (excepting from said larcel all the property and space comprising all the units thereof as defined and set forth in said Declaration and survey).

This deed is conveyed on the conditional limitation that the percentage of ownership of said granters in the common elements shall be divested protanto and vest in the grandes of the other units in accordance with the terms of said declaration and any amended declarations recorded pursuant thereto, and the right of revocation is also hereby reserved to the grantor herein to accomplish this result. Grantor also hereby grants to Grantee, its successors and assigns, as rights and easements appurtenant to the above described real estate, the rights and easements for the benefit of said property set forth in the aforementioned declaration.

This Deed is subject to all rights, easements, estrictions and reservations contained in said Declaration the same as though () a provisions of said Declaration were recited and stipulated at length herein.
