This Deed is made and executed upon and is subject to certain express conditions and covenants, said conditions and covenants being a part of the consideration for the property hereby conveyed and are to be taken and construed to comply with the said:

FIRST: The Grantee shall start renovation and reconstruction of said premises within 30 months after the date of delivery of the deed and complete said construction, considered as satisfactory, and in compliance with the City Code, within 30 months after the date of delivery of the deed.

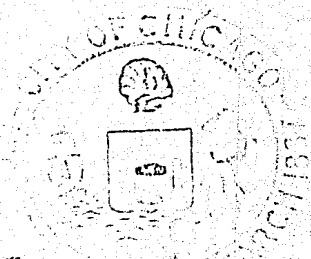
SECOND: The Grantee shall sell said property to a qualified buyer within three months of renovation of the property.

THIRD: In the event renovation of the property is unfeasible, the Grantee will demolish said property at its own expense.

FOURTH: The Grantee agrees for itself and any successor in interest not to discriminate upon the basis of race, religion, color, sex, or national origin in the sale, lease or rental or in the use or occupancy of the property hereby conveyed or any part thereof, or of any improvement erected or to be erected thereon or any part thereof, or in the demolition of the property.

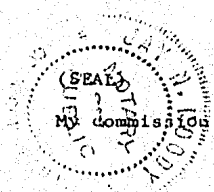
