

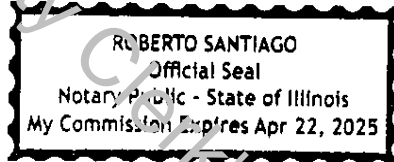

PERMITTED EXCEPTIONS
