THE COVENANTS, CONDITIONS AND PROVISIONS REFERRED TO ON PAGE 1 (THE REVERSE SIDE OF THIS TRUST DEED):

1. Mortgagors shall (1) promptly repair, restore or rebuild any buildings or improvements now or befeafter on the premises which may become damaged or be destroyed; (2) keep said premises in good condition and repair, without waste, and free from mechanic's or other hens, or claims for lien not expressly upon request exhibit satisfactory evidence of the descharge of such prior lien to Trustee or to holders of the merce; (3) pay when due any indebtedness which may be seried by a lien or charge on the premises superior to the hen hereof, and building or huildings now or at any time in process of evection upon wasted premises (5) comply with all requirements of law or municipal ordinalses with respect to the premises and the use thereof; (6) make no material alterations in said premises except as required by law or municipal ordinalses.

2.
