LOAN MODIFICATION AGREEMENT

This Loan Modification Agreement ("Agreement"), between MAKV E. PEREZ, AN UNMARRIED WOMAN, AS AN INDIVIDUAL, whose address is 2305 FLICKER, ROLL In C. MEADOWS, Illinois 60008 ("Borrower") and BMO Harris Bank, N.A., whose address is 1 Corporate Drive, Spine 360, Lake Zurich, Illinois 60047 ("Lender"), is effective November 10th, 2022, and amends and supplements (1) the Mortgage, Deed of Trust, or Security Deed (the "Security Instrument"), dated September 8th, 2003 and recorded in Book/Liber N/A, Page N/A. Instrument No. 0327602195, of the Official Records of COOK County, Illinois, and (2) are Note bearing the same date as, and secured by the Security Instrument, which was entered into as security for the prefermance of the Note and encumbers the real and personal property described and defined in the Security Instrument as the "Property," located at 2305 FLICKER, ROLLING MEADOWS, Illinois 60008,

the real property described being set forth as follows:
SEE EXHIBIT "A" ATTACHED HERETO AND MADE A PART HEREOF.

In consideration of the agreements made in this Agreement, and other good and valuable consideration which the parties agree they have received, including, but not limited to avoiding foreclosure and its related costs, the Borrower and Lender agree to modify the terms of the Note and Security Instrument (the "Loan Documents") as set forth in this Agreement. The Borrower and the Lender also agree that the provisions of this Agreement supersede and replace any inconsistent provisions set forth in the Loan Documents and any prior modification, forbearance or other loss mitigation agreement.

- 1. BORROWER REPRESENTATIONS AND COVENANTS. I certify and represent to Lender and otherwise pure and covenant with Lender that:
- (2) are experiencing a financial hardship, and as a result, (i) I am in default under the Loan Documents or my default in maximent, and (ii) I do not have sufficient income or access to sufficient readily available financial assets to make my monthly mortgage payments now or in the near future;
- (b) There has been no impermissible change in the ownership of the Property since I signed the Loan Documents:
- (c) I have provided required documentation for all income that I receive (and I understand that I am not required to disclose child support or alimony unless I chose to rely on such income when requesting to qualify mortgage assistance);
- (d) All documents and information I have provided to Lender in connection with this Agreement, including the documents and information regarding my eligibility for this modification, are true and correct;
- (e) I have made or will make all payments required under a trial period plan and have complied with all other requirements of such trial period plan; and
- (f) I will cooperate fully with Lender in intaining any title endorsement(s), or similar title insurance product(s), and/or subordination agreement(s) that are necessary or required by the Lender's procedures to ensure that my mortgage loan as modified by this Agreement is in first lien position and is fully enforceable upon modification and that if, under any circumstance and not vith standing anything else to the contrary in this Agreement, the Lender does not receive such title endorsement(s), title insurance product(s) and/or subordination agreement(s), then the terms of this Agreement will not become reflective on the Modification Effective Date and the Agreement will be null and void.
- 2. ACKNOWLEDGEMENTS AND PRECONDITIONS TO MCDIFICATION. I understand and acknowledge that:
- (a) If, prior to or as of the Modification Effective Date, the Lender detramines that any of my certifications or representations set forth in paragraph No.1 is untrue or any covenant or agree next set forth above in paragraph No.1 has not been performed, the Loan Documents will not be modified and this Agree nent, except for this paragraph is null and void and of no legal effect; and
- (b) The Loan Documents will not be modified by this Agreement unless and until och (i) the Lender has accepted this Agreement as solely evidenced by Lender's signature on this Agreement or on a coy of this Agreement containing Lender's signature, and (ii) the Modification Effective Date has occurred and the Lender will not be obligated or bound to make any modification of the Loan Documents if any certification or representation set forth above in paragraph No. Uses not been performed.

3. CAPITALIZATION AMOUNT.

I acknowledge that interest has accrued but has not been paid and the Lender also has incurred, paid or otherwise advanced taxes, insurance premiums and other expenses necessary to protect or enforce its interest in the Loan Documents and that such interest, costs and expenses, in the total amount of \$0,00, have been added to the principal balance owed under the Note and secured by the Security Instrument.

4. UNPAID PRINCIPAL BALANCE.

As of December 1st, 2022 the amount payable under the Loan Documents is U.S. \$78,449.12 (the "Unpaid Principal Balance"), consisting of the unpaid amount(s) loaned to Borrower by Lender plus the Capitalization Amount (se) forth in paragraph No.3.

5. BORROWER'S PROMISE TO PAY.

I premise to pay the Unpaid Principal Balance plus interest charged in accordance with paragraph No.6 to the order of Leader in accordance with the payment schedule set forth in paragraph No.7.

6. INTEREST.

Interest will be charged on the Unpaid Principal Balance at the yearly rate of 4.375% beginning on November 1st, 2022. The yearly rate of 4.375% will remain in effect until principal and interest are paid in full.

7. MONTHLY PAYMENTS AND DUE DATE.

I promise to make monthly plyments of principal and interest as set forth in the schedule below until the principal and interest and any other and any other and the Security Instrument are paid in full. My payment schedule for the modified Loan is as follows:

8. MATURITY DATE.

If on November 1st, 2062 (the "Maturity Date"), I still owe amounts under the Loan Doluments, as amended by this Agreement, I will pay these amounts in full on the Maturity Date.

9. TRANSFER OF THE PROPERTY OR BENEFICIAL INTEREST IN BORROWER.

As used in this paragraph, "Interest in the Property" means any legal or beneficial interest in the Property, including, but not limited to, those beneficial interests transferred in a bond for deed, contract for deed, instal meant sales contract or escrow agreement, the intent of which is the transfer of title by Borrower at a future

If all or any part of the Property or any Interest in the Property is sold or transferred (or if Borrower is not a natural person and a beneficial interest in Borrower is sold or transferred) without Lender's prior written consent, Lender may require immediate payment in full of all sums secured by the Security Instrument.

If Lender exercises this option, Lender shall give Borrower notice of acceleration. The notice shall provide a period of not less than 30 days from the date the notice is delivered or mailed and, within such period, Borrower must pay all sums secured by the Security Instrument. If Borrower fails to pay these sums prior to the expiration of this period, Lender may invoke any remedies permitted by the Security Instrument without further notice or demand on Borrower.

Lender shall not charge me for holding and applying the Funds, annually analyzing the escrow account, or verifying the Escrow Items, unless Lender pays me interest on the Funds and applicable law permits Lender to make such a charge. I will be in default if I do not comply with the terms of the Loan Documents, as modified by this Agreement; that all the rights an I remodies, stipulations, and conditions contained in the Security Instrument relating to default in the making of payments under the Security Instrument also apply to default in the making of the payments due under this Agreement; and that I will be in default if, during the loss mitigation application process, I or any persons or entities acting at my direction or with my knowledge or consent gave materially false, misleading, or inaccurate information or statements to Lender (or failed to provide Lender with material information) in connection with my mortgage loan or application for mortgage assistance, such material representations include, but are not limited to, representations concerning my income, hardship, Property, and occupancy of the Property;
- (d) Loan Documents Remain in Full Force and Effect Except as Modified. All covenants, agreements, stipulations, and conditions in the Loan Documents shall be and ren ain in full force and effect, except as modified by this Agreement, and none of the Borrower's obligations or liabilities under the Loan Documents shall be diminished or released by any provisions of this Agreement, nor shall big Agreement in any way impair, diminish, or affect any of Lender's rights under or remedies on the Loan Documents, vinether such rights or remedies arise thereunder or by operation of law. Also, all rights of recourse to which Lei der is presently entitled against any property or any other persons in any way obligated for, or liable on, the Loan Documents are expressly reserved by Lender. The Loan Documents as modified by this Agreement are duly valid, bin ling agreements, enforceable in accordance with their terms and are hereby reaffirmed;
- (e) Debt is not Satisfied or Released. Nothing in this Agreement shall be understood or construed to be a satisfaction or release in whole or in part of the Loan Documents;
- (f) Modification Costs and Expenses of Lender, I agree that all costs and expenses in arred by Lender in connection with this Agreement, including recording fees, title examination, and attorney's fees, shall be paid by the Borrower and shall be secured by the Security Instrument, unless stipulated otherwise by Lender;
- (g) Assignment of Agreement. I understand that I may not assign the Loan Documents or this Agreement to a buyer or transferee of the Property and, unless expressly agreed to by Lender in writing, such buyer or transferee will not be permitted to assume the Loan;
- (h) Execution of Documents. I agree to make and execute such other documents or papers as may be necessary or required to: (i) consummate the terms and conditions of this Agreement; or (ii) correct the terms and conditions of this Agreement if an error is detected after execution of this agreement and which, if approved and accepted by Lender, shall bind and inure to the heirs, executors, and administrators, of the Borrower or the Borrower's estate. Borrower represents that all persons who signed the Loan Documents or their authorized representative(s) have signed this Agreement, unless (i) a borrower or co-borrower is deceased; (ii) the borrower and co-borrower are divorced and the property has been transferred to one spouse in the divorce decree, the spouse who no longer has an interest in the property need not sign this Agreement (although the non-signing spouse may continue to be held liable for the obligation under the Loan Documents); or (iii) the Lender has waived this requirement in writing;
