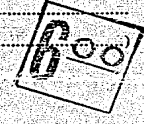

 considerations in hand paid, do hereby sell and convey unto said party of the second
 part, the following described real estate, situated in Cook County, Illinois, to wit:

LEGAL DESCRIPTION: Unit 507 as delineated in survey of the following described parcel of real estate (hereinafter referred to as "Parcel"):

Lot 143 and Lot 146 (except the South Eastern 100 feet thereof, measured on South Shore Drive) in Division 3 of South Shore Subdivision of the North Fractional half of Section 30, Township 38 North, Range 15, East of the Third Principal Meridian, together with a Resubdivision of Lots 1, 2, 4, 6, 16, 126, 127 and 128 of Division number 1 of Westfall's Subdivision of 208 acres, being the East half of the South West quarter and South East Fractional Quarter of Section 30, Township 38 North, Range 15, East of the Third Principal Meridian in Cook County, Illinois;

Grantor also hereby grants to grantees, their successors and assigns, as rights and easements appurtenant to the above described real estate, the rights and easements for the benefit of said property set forth in the Declaration made by La Salle National Bank, not personally, but as Trustee under Trust No. 12312 and recorded in the Office of Recorder of Deeds of Cook County, Illinois as Document No. 23009038.

This deed is subject to: (1) all rights, easements, restrictions, conditions, covenants and reservations contained in said Declaration, the same as though the provisions of said Declaration were recited and stipulated at length herein; (2) private and public utility easements; (3) general taxes for the year 1975 and subsequent years; (4) the lien of additional taxes which may be assessed for 1975 by reason of the construction of new or additional improvements during that year and extended for collection on the 1975 or subsequent collector's warrant; and (5) Condominium Property Act.



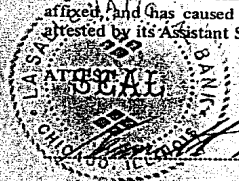

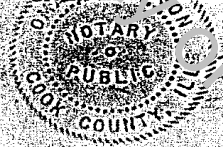
