This Waiver and Disclaimer is attached to and made a part of a certain Condominium Purchase Agreement dated March 11, 2020 (the "Purchase Agreement") by and between 1147 Jackson LLC, an Illinois limited liability company ("Seller"), and Varun Sharma and Megha Ghildiyal ("Purchaser") for the sale of Dwelling Unit PH-A located at 313 S.
