LENDER AGREFMENT TO SUBORDINATE TO RENTAL ASSISTANCE DEMONSTRATION USE AGREEMENT

ROC SEVELT SQUARE RENTAL

This Agreement to Subordinate 'o Rental Assistance Demonstration Use Agreement (the "Subordination") is entered into as of this 10 day of January, 2023, by BMO Harris Bank N.A.., a national banking association and CIBC FANK USA, an Illinois state chartered bank (the "Lender"), and RS Affordable I LLC, and Illinois limited liability company (the "Affordable Owner") and RS Market I LLC, an Illinois limited liability company (together with the Affordable Owner, the "Owner"), collectively, the ("Parties").

WHEREAS, the Parties executed that certain Construction Funding Agreement dated as of January 10, 2023 (the "Affordable Loan Agreement") and that certain Construction Loan Agreement dated as of January 10, 2023 (the "Market Loan Agreement" together with the Affordable Loan Agreement, the "Loan Agreement") and Owner executed certain promissory notes (collectively, the "Notes") to evidence two separate loans (the "Suboruince Loans") to Owner; and

WHEREAS, the Owner executed that certain Multifamily Mortgage, Assignment of Rents, Security Agreement and Fixture Filing dated and recorded as of substantially even date herewith (the "Affordable Mortgage") for the benefit of the City of Chicago, a municipality and home rule unit of local government duly organized and validly existing under the constitution and laws of the State of Illinois ("Governmental Lender"). The Owner also executed that certain Leasehold Mortgage, Security Agreement, Assignment of Leases and Rents, and Fixture Filing dated and recorded as of substantially even date herewith (the "Market Mortgage,") for the benefit of the Lender. The Affordable Mortgage and Market Mortgage are collectively referred herein as the "Mortgage"; and

WHEREAS, certain UCC Financing Statements (the "UCC Financing Statement") have been or are intended to be filed in connection with the Mortgage;

WHEREAS, the Affordable Owner and the Chicago Housing Authority executed that certain Subordination Agreement (CHA) dated and recorded as of substantially even date herewith ("Subordination Agreement (CHA)");

WHEREAS, the Affordable Owner and Heartland Housing, Inc., a not for profit corporation, executed that certain Subordination Agreement(TIF Sponsor Loan/Seller Loan) (together with the Subordination Agreement (CHA), the "Subordination Agreements") dated and recorded as of substantially even date herewith.

WHEKEAS, the Governmental Lender executed that certain Assignment of Mortgage and Loan Documents sated as of January 1, 2023, to be recorded substantially concurrently herewith (the "Assignment of Mortgage"), which Assignment of Mortgage assigns to Lender all of Governmental Lender's right, title and interest in and to, subject to the provisions of the Assignment of Mortgage, the Loan Agreement, the Mortgage, the Notes, the Subordination Agreements and certain other documents executed in connection with the transaction contemplated thereby (collectively, the "Subord'nate Documents"); and

WHEREAS, HUD authorized the conversion of one hundred twenty-five (125) units at Roosevelt Square I (the "Project") to be located upon the real property described on Exhibit "A" attached hereto, from public housing to Section 8 assistance under the Rental Assistance Demonstration ("RAD") program, pursuant to Puolic Law 112-55; and

WHEREAS, as a condition of the RAD conversion, the Owner executed a Rental Assistance Demonstration Use Agreement dated and recorded as of substantially even date herewith (the "RAD Use Agreement") for the benefit of HUL; and

WHEREAS, HUD requires as a condition of the RAD conversion that the Parties agree to subordinate the Subordinate Document(s) to the RAD Use Agreement;

NOW THEREFORE, let it be known to all interested parties, that for good and valuable consideration, the receipt of which is hereby acknowledged, the undersigned do hereby agree:

- 1. So long as the RAD Use Agreement, as assigned to Owner as of even date herewith, and all extensions thereto, be in effect, the Subordinate Document(s) shall in all respects be subordinate in priority to the RAD Use Agreement.
- 2. Subordination of the Subordinate Documents extends to and continues in effect with respect to any future amendment, extension, renewal, or any other modification of the RAD Use Agreement or the Subordinate Document(s) which have been approved by the Lender in writing.
- 3. In the event of conflict between/among the Subordinate Document(s) and the RAD Use Agreement, the RAD Use Agreement controls.

- 4. The following amendments to the Subordinate Document(s) require the prior written consent of HUD: Any amendment to any HUD-required provisions in the Subordinate Document(s), an increase in the interest rate, an increase of the total indebtedness, an acceleration of the amortization or payment schedule, and any changes that would preclude or impair a reasonable opportunity to cure any defaults by the Project Owner under the Subordinate Documents.
- 5. This Subordination will survive bankruptcy and foreclosure.
- 6. This Subordination may be signed in counterparts.
- 7. The invalidity, in whole or in part, of any of the provisions set forth in this Subordination, shall not a feet or invalidate any remaining provisions.
- 8. This Subordination and every covenant hereof shall be binding upon the Parties and their respective successors and assigns. This Subordination shall not be modified or amended except by a written instrument executed by all parties hereto and approved in writing by HUD.
- 9. It is expressly understood and agree I that except for the subordination specifically intended and accomplished by this Agreement, the Subordinate Documents shall be and remain in full force and effect.
- 10. The Market Loan Agreement and Market Mongage shall be automatically released from this Subordination upon recording of an executed release pursuant to Section 12.29 of the Market Loan Agreement, which releases the lien and security interest of the Affordable Parcel Units, as defined therein, from the Market Mongage
- 11. This Agreement is made under and shall be governed by the lay's of the State of Illinois.
