SYBORDINATION AGREEMENT (CHA Loans)

THIS SUBORDINATION! AGREEMENT ("Agreement") is made as of January 10, 2023, by and among RS AFFORDABLE I LLC, so Illinois limited liability company ("Borrower"), with a mailing address of 350 W Hubbard Street, Suite 300 Chicago, Illinois 60654, CHICAGO HOUSING AUTHORITY, an Illinois municipal corporation ("Junior Lienholder"), with a mailing address of 60 East Van Buren Street, Chicago, Illinois 60605, BMO HAPPIS BANK N.A., a national banking association (together with its successors and assigns, the "BMO Harris"), with a mailing address of 320 South Canal, 15th Floor, Illinois 60606, and CIBC BANK USA, an Illinois state chartered bank ("CIBC," and together with BMO Harris, singly a "Senior Lender" and collectively, the "Senior Lenders"), with a mailing address of 120 S. LaSalle Street, Chicago, Illinois 60603.

RECITALS

Borrower has requested that Senior Lender enter into that certain Funding Loan Agreement, dated as of January 1, 2023 (the "Funding Loan Agreement"), by and among the Senior Lenders, as funding lenders, and the City of Chicago, an Illinois municipal corporation of Governmental Lender"), as borrower, under the terms of which the Senior Lenders will make a loan (the Funding Loan") to the Governmental Lender in the maximum aggregate principal amount of Seventy-Six Million Two Hundred Fifty Thousand and No/100 Dollars (\$76,250,000.00). To evidence the Funding Loan, the Governmental Lender has executed and delivered (i) to CIBC, its not to exceed \$38,125,000.00 City of Chicago Multi-Family Housing Revenue Note, Series 2023A (Roosevelt Square Phase 3B) (the "Governmental Lender Note, Series 2023A"), (ii) to BMO Harris, its not to exceed \$13,875,000.00 City of Chicago Multi-Family Housing Revenue Note, Series 2023B-1 (Roosevelt Square Phase 3B) (the "Governmental Lender Note, Series 2023B-1,") and (iii) to BMO Harris, its not to exceed \$24,250,000.00 City of Chicago Multi-Family Housing Revenue Note, Series 2023B-2 (Roosevelt Square Phase 3B) (the "Governmental Lender Note, Series 2023B-2,") (each a "Governmental Lender Note" and collectively, the "Governmental Lender Notes"). The Funding Loan Agreement, the Governmental Lender Notes and all other documents executed and delivered to evidence and secure or otherwise relating to, the Funding Loan are referred to hereinafter collectively as the "Funding Loan Documents").

- B. The proceeds of the Funding Loan are being loaned by Governmental Lender to the Borrower (the "Senior Loan") under that certain Borrower Loan Agreement, dated as of January 1, 2023 (the "Senior Loan Agreement"), between the Governmental Lender and the Borrower to finance the acquisition, construction and development of 314 affordable rental units and related Improvements on multiple scattered sites on the Borrower's leasehold estate in the land and air rights (collectively, the "Land") situated in the City of Chicago, Cook County, Illinois, and more particularly described on Exhibit A attached hereof (collectively, the "Project"). The Land and the Project are referred to hereinafter collectively as the "Property."
- C. The Senior Lenders shall make disbursements of the Funding Loan, and correspondingly as agent for the Governmental Lender, disbursements of the Senior Loan to the Borrower, pursuant to the Funding Loan Agreement and that certain Construction Funding Agreement, of even date herewith, (the "Construction Funding Agreement"), between the Borrower and Senior Lenders. Pursuant to the Construction Funding Agreement, BMO Harris has been designated and appointed as administrative agent for the Senior Lenders and, for purposes of this Agreement, references to Senior Lenders shall be deemed to include BMO Harris, as administrative agent for the Senior Lenders.
- D. The Senier Loan is evidenced by (i) that certain Promissory Note-Series 2023A Borrower Loan, Roosevelt Square Phase 1B, dued as of the date hereof, in the stated principal amount of \$38,125,000 (as it may be amended, supplemented or replaced from time to time, the "Series A Borrower Note"), made by Borrower and payable to the order of Governmental Lender, (ii) that certain Promissory Note-Series 2023B-1 Borrower Loan, Roosevelt Square Phase 3B, dated as of the date hereof, in the stated principal amount of \$13,875,000 (as it may be amended, supplemented or replaced from time to time, the "Series B-1 Borrower Note-Series 2023B-2 Borrower Loan, Roosevelt Square Phase 3B, dated as of the date hereof, in the stated principal amount of \$24,250,000 (as it may be amended, supplemented or replaced from time to time, the "Series B-2 Borrower Note" and, together with the Series A Borrower Note and the Series B-1 Borrower Note, as the context requires, singly a "Senior Note" and collectively, the "Senior Notes"), made by Borrower and payable to the order of Governmental Lender
- E. The Senior Loan is secured by, among other things, that certain Leasehold Mortgage, Security Agreement, Assignment of Leases and Rents, and Fixture Filing, dated as of the date hereof, executed by Borrower for the benefit of Governmental Lender (the "Senior Atorigage," and, together with the Senior Note, the Senior Loan Agreement, the Construction Funding Agreement, the Funding Loan Documents and all other documents executed in connection with the Senior Loan, including this Agreement, are referred to hereinafter as the "Senior Loan Documents"), which Senior Mortgage encumbers the Property and the interest of RS Market I LLC, an Illinois limited liability company, in other real property, as more particularly described in the Senior Mortgage. The Senior Mortgage is being recorded concurrently herewith in the Office of the Clerk of Cook County, Illinois ("Official Records").
- F. The Governmental Lender's rights and interests (except for certain unassigned rights) in the Senior Note, the Senior Mortgage, the Senior Loan Agreement and the other Senior Loan Documents are being assigned by Governmental Lender to Senior Lender to secure the Funding Loan.
- G. As used herein, the term "Senior Indebtedness" means any and all indebtedness, claims, debts, liabilities or other obligations of the Borrower to Senior Lenders under the Senior Loan Documents, together with all interest accruing thereon and all costs and expenses, including attorneys' fees, of collection thereof, whether the same accrues or is incurred before or after the commencement of any bankruptcy case by or against Borrower.

- H. Pursuant to the Senior Mortgage and the other Senior Loan Documents, Borrower is not permitted to accept any loans secured by the Property or to further encumber the Property without the prior written consent of Senior Lender, which consent may be withheld in Senior Lender's sole discretion. The Borrower has requested the Senior Lender permit the Junior Lienholder to make (a) a loan to the Borrower in an amount not to exceed \$2,250,000.00.00 (the "DTC Loan") (b) a seller financing loan to Borrower in the principal amount of \$2,044,444.00 (the "Seller Financing") and (c) a loan to the Borrower in an amount not to exceed \$43,500,000.00 (the "MTW Funds Loan," and together with the DTC Loan and the Seller Financing, collectively, the "Junior Loans"). Each of the documents listed on Exhibit B together with all other documents and materials entered into with the Junior Lienholder with respect to the Junior Loans shall be referred to collectively as the "Junior Obligation Documents".
- I. As used herein, the term "Junior Obligations" means the Junior Loans and any and all indebtedness, c'zims, debts, liabilities or other obligations from Borrower to Junior Lienholder under the Junior Obligation Documents, together with all costs and expenses, including attorneys' fees, of collection thereof, whether the same accrues or is incurred before or after the commencement of any bankruptcy case by or against Borrower.
- J. It is a condition precedent to Senior Lender to entering into the Senior Loan Documents and permitting the recordation of the recordable Junior Obligation Documents that the Senior Mortgage and the other Senior Loan Documents to and remain at all times a lien or charge upon the Property, prior and superior to the liens or charges of the Junior Obligation Documents.
- K. Senior Lenders are willing to permit the recordation of the recordable Junior Obligation Documents, provided that (1) the Senior Mor.gage and the other Senior Loan Documents are and shall remain a lien or charge upon the Property prior and superior to the liens or charges of the Junior Obligation Documents, and (2) Junior Lienholder will expressly subordinate the liens or charges of the Junior Obligation Documents to the lien or charge of the Senior Loan Documents.
- L. Junior Lienholder is willing that the Senior Lean Documents shall constitute a lien or charge upon the Property which is prior and superior to the liens or charges of the Junior Obligation Documents. The parties hereto enter into this Agreement for the purposes set forth in these Recitals.
- M. Capitalized terms used herein and not otherwise defined shall have the meanings set forth for them in the Senior Loan Agreement and Construction Funding Agreement, respectively.

AGREEMENT

NOW, THEREFORE, in consideration of the mutual benefits accruing to the parties hereto and other valuable consideration, the receipt and sufficiency of which consideration is hereby acknowledged, and in order to induce Senior Lenders to make the Senior Loan, it is hereby declared, understood, and agreed as follows:

Lenders, and all amendments, modifications, extensions and renewals thereof shall unconditionally be and remain at all times a lien or charge on the Project prior and superior to the lien or charge of the Junior Obligation Documents. Junior Lienholder intentionally and unconditionally subordinates the lien or charge of the Junior Obligation Documents in favor of the lien or charge upon the Property of the Senior Mortgage and other Senior Loan Documents in favor of Senior Lenders, and understands that in reliance upon and in consideration of this subordination, specific loans and advances are being and will be made and, as part and parcel thereof, specific monetary and other obligations are being and will be entered into which would not be made or entered into but for said reliance upon this subordination.

- 2. Only Agreement Regarding Subordination. Senior Lenders would not permit the recordation of any Junior Obligation Documents without this Agreement. This Agreement shall be the whole and only agreement with regard to the subordination of the lien or charge of the Junior Obligation Documents to the lien or charge of the Senior Mortgage and the other Senior Loan Documents and shall supersede and cancel, but only insofar as would affect the priority between said mortgages and said covenants, conditions and restrictions, any prior agreements as to such subordination, including, but not limited to, those provisions, if any, contained in the Junior Obligation Documents which provide for the subordination of the lien or charge thereof to another deed or deeds of trust or to another mortgage or mortgages.
- 3. <u>Loan Disbursements</u>. In making disbursements pursuant to any of the Senior Loan Documents Senior Lenders is under no obligation or duty to, nor has Senior Lenders represented that it will, see to the application of such proceeds by the person or persons to whom Senior Lenders disburses such proceeds, and any application or use of such proceeds for purposes other than those provided for in such Senior Loan Document(s) shall not defeat the subordination herein made in whole or in part.
- 4. <u>Consent and Approval.</u> Junior Lienholder consents to and approves the Senior Loan Documents, including but not limited to any existing or future extension, modification and/or amendment of said documents between Borowa and Senior Lenders. No decision by Junior Lienholder to review or not review the Senior Loan Documents, including but not limited to the disbursement provisions contained therein, shall impair or otherwise limit the enforceability of this Agreement.
 - 5. Other Agreements. Junior Lie molder and Borrower declare, agree, and acknowledge that:
- 5.1 <u>Subordination of Indeb edness.</u> Any and all Junior Obligations are hereby subordinated and subject to any and all Senior Indeb edness, as set forth herein.
- Documents, if required, as long as all such payments under the Junior Obligation Documents are made solely from Net Cash Flow, as provided in Section 7.03(a) of the Porrower's Operating Agreement and all payments under the Senior Mortgage and the other Senior Loan Documents are current and not delinquent or in arrears, and only so long as at the time of such payment: (i) no Event of Default exists under the Construction Funding Agreement or any of the other Senior Loan Documents and no event exists which, with the lapse of time or the giving of notice or both, would be an Event of Default under the Senior Indebtedness of which Junior Lienholder has received notice; and (ii) the payment would not result in a violation of any of Borrower's financial covenants set forth in any of the Senior Loan Documents ("Permitted Payments").
- Indebtedness now or hereafter existing shall be first paid in full by Borrower before any payment shall be made by Borrower on the Junior Obligations, and (b) this priority of payment shall apply at all times until all of the Senior Indebtedness has been repaid in full. In the event of any assignment by Borrower for the benefit of Borrower's creditors, or any bankruptcy proceedings instituted by or against Borrower, or the appointment of any receiver for Borrower or Borrower's business or assets, or of any dissolution or other winding up of the affairs of Borrower or of Borrower's business, and in all such cases respectively, Borrower's officers and any assignee, trustee in bankruptcy, receiver and other person or persons in charge are hereby directed to pay to Senior Lenders or BMO Harris, as administrative agent for the Senior Lenders, the full amount of the Senior Indebtedness before making any payments to Junior Lienholder due under the Junior Obligations.

- 5.4 <u>Return of Prohibited Payments</u>. Except as otherwise expressly agreed to herein, if Junior Lienholder shall receive any payments or other rights in any property of Borrower in connection with the Junior Obligations in violation of this Agreement, such payment or property shall immediately be delivered and transferred to BMO Harris, as administrative agent for the Senior Lenders, after written notice to Junior Lienholder.
- 5.5 <u>Repayment of Senior Indebtedness</u>. This Agreement shall remain in full force and effect until all amounts due under the Senior Notes and the Senior Loan Agreement and the other Senior Loan Documents are fully repaid in accordance with their respective terms and all of the terms of this Agreement have been complied with.
- 5.6 <u>Standstill</u>. Junior Lienholder agrees that, without the Senior Lenders' prior written consent, it will not accelerate the Junior Obligations, commence foreclosure proceedings with respect to the Property, collect rents, appoint (or seek the appointment of) a receiver or institute any other collection or enforcement act or.

- 7. <u>Bankruptcy Prov sions</u>. To the extent any payment under any Senior Loan Document (whether by or on behalf of Borrower, as proceeds of security or enforcement of any right of set-off, or otherwise) is declared to be fraudule at or preferential, set aside or required to be paid to a trustee, receiver or other similar party under the Bankri ptcy Code or any federal or state bankruptcy, insolvency, receivership or similar law, then if such payment is recovered by, or paid over to, such trustee, receiver or other similar party, the Senior Indebtedness or part thereof originally intended to be satisfied shall be deemed to be reinstated and outstanding as if sucl payment had not occurred.
- Casualty Insurance Proceeds; Condemnation Proceeds. In the event Senior Lenders, or 8. BMO Harris, as administrative agent for the Senior Lenders, s'all release, for the purposes of restoration of all or any part of the improvements, its right, title and interest in and to the proceeds under policies of insurance thereon, and/or its right, title and interest in and to any awards, or its right, title and interest in and to other compensation made for any damages, losses or compensation for other rights by reason of a taking in eminent domain, Junior Lienholder shall simultaneously release (and hereby agrees that it shall be irrevocably and unconditionally deemed to have agreed to release) for such purpose all of Junior Lienholder's right, title and interest, if any, in and to all such insurance proceeds awards or compensation. Junior Lienholder agrees that the balance of such proceeds remaining after such resonation, or all of such proceeds in the event Senior Lenders, or BMO Harris, as administrative agent for the Senior Lenders, elects, in accordance with Illinois law and the Senior Loan Documents, not to release any such proceeds for any such restoration, shall be applied to the payment of amounts due under the Senior Loan Documents until all such amounts have been paid in full, prior to being applied to the payment of any amount due under the Junior Obligation Documents. If Senior Lenders, or BMO Harris, as administrative agent for the Senior Lenders, holds such proceeds, awards or compensation and/or monitors the disbursement thereof, Junior Lienholder agrees that Senior Lenders, or BMO Harris, as administrative agent for the Senior Lenders, may also elect, in their/its sole and absolute discretion, to hold and monitor the disbursement of such proceeds, awards and compensation to which Junior Lienholder is or may be entitled. Nothing contained in this Agreement shall be deemed to require Senior Lenders or BMO Harris, as administrative agent for the Senior Lenders, in any way whatsoever, to act for or on behalf of Junior Lienholder or to hold or monitor any proceeds, awards or compensation in trust for or on behalf of Junior Lienholder, and all or any of such sums so held or monitored may be commingled with any funds of Senior Lenders or BMO Harris, as administrative agent for the Senior Lenders.

- 9. <u>Effect of Other Agreements</u>. The relationship between Borrower and Senior Lenders under the Senior Loan Documents is, and shall at all times remain, solely that of borrower and lender. Based thereon, Junior Lienholder acknowledges and agrees that Senior Lenders neither undertake nor assume any fiduciary responsibility or other responsibility or duty to Borrower or Junior Lienholder to guarantee or assist in Borrower's or Junior Lienholder's performance under any of the agreements between those parties and other third parties, including without limitation the Junior Obligation Documents.
- Miscellaneous. This Agreement may be executed in multiple counterparts and the 10. signature page(s) and acknowledgment(s) assembled into one original document for recordation, and the validity hereof shall not be impaired by reason of such execution in multiple counterparts. This Agreement is to be governed according to the laws of the State of Illinois. Wherever possible each provision of this Agreement shall be interpreted in such a manner as to be effective and valid under applicable law but if any provision of this Agreement shall be prohibited by or invalid under such law, such provision shall be ineffective to the extent of such prohibition or invalidity, without invalidating the remainder of such provision or the remaining provisions of this Agreement. In the event of action, suit, proceeding or arbitration to enforce any term of this Agreement, the prevailing party shall be entitled to recover from the non-prevailing party, as determined by the court or arbitrator, all of the prevailing party's costs and expenses, including without limitation reasonable attorneys' fees and expert witness fees, incurred by the prevailing party in connection there with. If Junior Lienholder or any affiliate of Junior Lienholder shall acquire, by indemnification, subrogation or otherwise, any lien, estate, right or other interest in the Property, that lien, estate, right or other interest shall be subordinate to the Senior Mortgage and the other Senior Loan Documents as provided herein, and Junior Lienholder hereby waives, on behalf of itself and such affiliate, until all amounts owed under the Scoror Loan Documents have been indefeasibly paid in full and all Senior Lenders' obligations to extend credit under the Senior Loan Documents have terminated, the right to exercise any and all such rights it may acquire by indemnification, subrogation or otherwise. The Agreement shall inure to the benefit of, and the birding upon, the parties hereto and the respective successors and assigns.
- 11. <u>Notices</u>. Any notice, demand, request or ofter communication which any party hereto may be required or may desire to give hereunder shall be in writing and shall be deemed to have been properly given (a) if hand delivered, when delivered; (b) if mailed by United States Certified Mail (postage prepaid, return receipt requested), three Business Days after mailing; or (c) if by Federal Express or other reliable overnight courier service, on the next Business Day after delivered to the address for each party hereto first listed above.
- 12. Refinancing of the Senior Loan. Junior Lienholder further agrees the its agreement to subordinate hereunder shall extend to any new or amended and restated mortgage debt which is for the purpose of refinancing the outstanding principal amount of, and accrued interest and other sums then due with respect to, the Senior Loan or any portion thereof and including reasonable and necessary costs associated with the closing and/or the refinancing. In the event of any such new mortgage debt, Junior Lienholder shall execute and deliver to the new lender a new subordination agreement on the same terms and conditions as this Subordination Agreement.
