- 2. Funds for Taxes and Insurance. If the amount of the Funds held by Lender, together with the future monthly installments of Funds payable prior to the due dates of taxes, assessments, insurance premiums and ground rents as they full due, such excess shall be, at Borrower's option, either promptly repaid to Borrower or credited to Borrower on monthly installments of Funds. If the amount of the Funds held by Lender shall not be sufficient to pay taxes, assessments, insurance premiums and ground rents as they fall due, Borrower shall pay to Lender any amount necessary to make up the deficiency in one or more payables as Lender may require.

Upon payment in full of all sums secured by this Mortgage, Lerue, shall promptly refund to Borrower any Funds beld by Lender. If under paragraph 17 hereof the Property is sold or the Prope ty is otherwise acquired by Lender, Lender shall apply, no later than immediately prior to the sale of the Property or its acquisition of Lender, any Funds held by Lender at the time of application as a credit against the sums secured by this Mortgage.

3. Application of Payments. If Lender receives a payment from Borrower for a delinquent periodic payment whic't includes a sufficient amount to pay any late charge due, the payment may be applied to the delinquent payment and the late charge. It more than one periodic payment is outstanding, Lender may apply any payment received from Borrower to the repayment of the payments if, and to the extent that, each payment can be paid in full. To the extent that any excess exists after the payment is applied to the full payment of one or more periodic payments, such excess may be applied to any late charges due. 5. Hazard Insurance. - 15. Rehabilitation Loan Agreement.
