NOTICE OF PRIORITY DEMOLITION LIEN

## <u>AFFIDAVIT IN SUPPORT OF NOTICE OF LIEN</u>

- I, Gary Miller, being first duly sworn on oath, depose and state as follows:
  - 1. I was the duly authorized and acting Director of Code Enforcement for the City of Chicago Heights, Cook County, Illinois, and I have personal knowledge of the facts and circumstances set forth in the foregoing Notice of Lien;
  - 2. I personally inspected the below listed property and found the structure located thereupon to be open and vacant, dangerous and unsafe, thereby constituting at immediate and continuing hazard to the health, safety, and welfare of the surrounding community;
  - 3. I personally participated in the demolition process involving the above-described property and affirmatively state that the notices, publications, signage, costs, and dates repring thereto, set forth in the Notice of Lien are true and correct to the best of my knowledge and said demolition activities were performed and said demolition and removal costs were incurred in accordance with 65 LCS 5/11-31-1(e);
  - 4. The demolition of the structure located on the property concluded on Angust 27, 2022 and \$27,615.01 in expenses were incurred by the City of Chicago Heights in said demolition;
  - 5. A Notice, which was not less than 2 feet by 2 feet in size, was posted on the front cine building located upon the above-listed property. The notice was dated as of the date of the posting and stried that unless the building was demolished, repaired, or enclosed, and unless any garbage, debris, and other hazardous, noxious, or unhealthy substances or materials were removed so that an immediate and continuing no zard to the community no longer existed, then the building may be demolished, repaired, or enclosed, or any garbage, debris, and other hazardous, noxious, or unhealthy substances or materials may be removed, by the municipality;
  - 6. Service of Notices to Remediate stating that it was the intent of the municipality to demolish, repair, or enclose the building or remove any garbage, debris, or other hazardous, noxious, or unhealthy substances or materials if that action is not taken by the owner or owners were sent via certified mail, return receipt requested, to all owners of record and/or interested parties and recorded with the Cook County Recorder of Deeds;
  - 7. On 12/17, 18, & 19, 2021, a notice setting forth (i) the property index number and the address of the building, (ii) a statement that the property is open and vacant and constitutes an immediate and continuing hazard to the community, and (iii) a statement that the municipality intends to demolish, repair, or enclose the building or remove any garbage, debris, or other hazardous, noxious, or unhealthy substances or materials if the owner or owners or lienholders of record failed to do so was published in the Chicago Sun Times Newspaper, a newspaper published or circulated in the municipality where the building was located, for 3 consecutive days;
