On about August 12, 2021, on which date Owner still awned the aforementioned property, Contractor entered into a contract with Claimant to provide carpentry labor and materials on the building and improvements on the aforementioned property, at a contract price of \$ 425,000.00, and subsequently the contract was modified to include an additional \$ 62,630.00 of extra work and materials, for a total contract price of \$ 487,630.00; which contract price was to be paid incrementally upon completion of the aforesaid work; and that the Contractor failed to pay the Claimant said incremental payments; so that an October 12, 2022, the claimant discontinued all work under said contract.
- 3. There is now justly due and owing to the claimant, after allowing to the owner all credits, deductions and set-offs, \$ 115,000.00, which is still due and unpaid, plus interest from October 12, 2022.
- 4. Claimant now claims a lien on the aforementioned property and all improvements on it, against the owner and all persons interested, and also claims a lien on any amounts due from the owner to the original contractor, for \$ 115,000.00, together with interest, according to statute.
