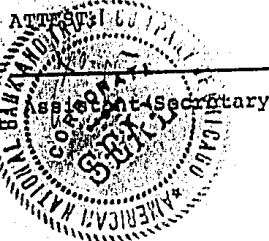
TO HAVE AND TO HOLD said premises not in tenancy in common but in JOINT TENANCY with rights of survivorship forever.
