I, (Name) Linda L Doyle, being duly sworn on oath, state that I/We own or are acting as the attorney in fact on behalf of the owner and state that this property 11560 S Nagle Ave., Worth, IL 60482, and the attached deed is not in violation of the Plat Act, Ch. 765 ILCS 205/1.1(b), as the provisions of this Act do not apply and no plat is required due to the following allowed exception (Circle the number applicable to the attached deed):

1. The division of subdivision of land into parcels or tracts of 5 acres or more in size which does not involve any new streets or easements of access;
