That part of the South 1/2 of Lot 11 described as follows:

Beginning at a point in the South line of Lot 11, 200 feet easterly from the South West corner thereof; thence westerly along the South line of Lot 11 to the South West corner thereof; thence northerly along the west line of Lot 11 to a point in said west line equi-distant from the North West corner and the South West corner thereof; thence 100 feet in an easterly direction along a straight line running between the point in the line of the West line of said lot 11 equi-distant from the North West corner and the South West corner thereof and a point in the east line of lot 11 equi-distant from the North East corner and the South East corner thereof; thence from said point in last said mentioned line 200 feet easterly from the west line of said lot southward by a straight line to the place of beginning, all in the subdivision of Lots 1 to 17 inclusive and Lots 24 to 32 inclusive in Block H in Morgan Park according to the plat thereof recorded January 15, 1873 in book 3 of plats, page 71 as Document No. 78663, in Cook County, Illinois.
