Claimant states the follows:

1. Based on information and belie, on and prior to and subsequently, Owner owned fee simple title to the Real Estate (including all (and and improvements thereon) (Real Estate) in Cook County, Illinois, commonly known as 39.11 S. On or about August 13 2021 Claimant entered a contract (Contract) with Amber Motel Inc, known as trust no.19927 under which Claimant agreed to provide General Contracting Services for Owner in connection with contemplated improvements on the Real Estate for the original contract amount of \$ 1,502,237.50
- 3. The Contract was entered into by Amber Motel Inc. known as trust no.19927 as Owner, and the work was performed with the knowledge and consent of Owner.
- 4. Claimant performed extra and additional work in the amount of \$ 127,800.00 at the request of Amber Motel Inc. known as trust no.19927 as Owner, so that the final adjusted sum was \$ 1,630,037.50
- 5. Claimant completed all the work required by the contract and change order and its last day of work was December 22 2022

6. As of the date heleof, there is due, unpaid, and owing to Claimant, the Principal sum of \$ 1,630,037.50, which principal amount bears interest at the statutory rate of 10 percent per annum. Claimant claims a lien on the Real Estate (including all land and improvements thereon) in the amount of \$ 1,630,037.50 plus interest and attorney's fees.

7. Claimant revokes any waiver of rights for which Claimant has not received payment.
