THIS INDENTURE, made this 17th day of March, 1975, between THE NATIONAL BANK OF ALBANY PARK IN CHICAGO, a national banking association, as Trustee under the provisions of a deed or deeds in trust, duly recorded and delivered to said Bank in pursuance of a trust agreement dated the 16th day of August, 1966, and known as Trust Number 11-1558, party of the first part, and NIKOLA BUSESKI and ANKICA BUSESKA, his wife, party of the second part.
