Except as otherwise described in this Section 2, if Lender applies a payment, such payment will be applied to each Periodic Payment in the order in which it became due, beginning with the oldest outstanding Periodic Payment, as follows: first to interest and then to principal due under the Note, and finally to Escrow Items. If Lender files, negotiates, or settles a claim, Borrows, agrees that any insurance proceeds may be made payable directly to Lender without the need to include Borrower as an adminional loss payee. Lender may use the insurance proceeds either to repair or restore the Property (as provided in Section 5 (d)) or to pay amounts unpaid under the Note or this Security Instrument, whether or not then due.
- 6. Occupancy Bo rower must occupy, establish, and use the Property as Borrower's principal residence within 60 days after the execution of this Security Instrument and must continue to occupy the Property as Borrower's principal residence for at least one year after the date of occupancy, unless Lender otherwise agrees in writing, which consent will not be unreasonably withheld, or unless extenuating circumstances exist that are beyond Borrower's control.

Securing the Property includes, but is not limited to, exterior and interior inspections of the Property, entering the Property to make repairs, changing locks, replacing or boarding up doors and windows, draining water from pipes, eliminating building or other code violations or dangerous conditions, and having utilities turned on or off. Although Lender may take action

- (b) Avoiding Foreclosure; Mitigating Losses. (c) Application of Miscellaneous Proceeds upon Condemnation, Destruction, or Loss in Value of the Property. 17. Governing Law; Severability; Rules of Construction. This Security Instrument is governed by federal law and the law of the State of Illinois.
