Grantor also hereby grants to grantees, their successors and assigns, as rights and easements appurtenant to the above described real estate, the rights and easements for the benefit of said property set forth in the Declaration made by La Salle National Bank, not personally, but as Trustee under Trust No. 12312 and recorded in the Office of Recorder of Deeds of Cook County, Illinois as Document No. 23009026.
