Words used in multiple sections of this document 2.e defined below and other words are defined elsewhere in this document. Certain rules regarding the usage of words used in this dreument are also provided in Section 14.

"Security Instrument" means this document, which is dated FEBRUARY 24, 2023, together with all riders to this document.

"Borrower" is ERYCKA A ROLDAN AKA ERYCKA A REYES AND AURELIO SAUL ROLDAN VARGAS, MARRIED TO EACH OTHER. The Borrower's address is 2908 73RD AVF., ELMWOOD PARK, IL 60707 US. Borrower is the mortgagor under this Security Instrument.

"Co-Grantor" means any Borrower who signs this Security Instrument ov. does not execute the Debt Instrument.

"Lender" is The Huntington National Bank, a national banking association, whose address is Department GW0214, 5555 Cleveland Avenue, Columbus, OH 43231 (NMLSR ID: 402436). Lender is the mortgaged under this Security Instrument.

"Debt Instrument" means the loan agreement or other credit instrument signed by Corrower and dated the same day as this Security Instrument. In the event of loss and subject to the rights of any lienholder with rights to insurance proceeds that are superior to Lender's rights, the following provisions in this Section 4 shall apply. Borrower shall give prompt notice to the insurance carrier and Lender. Lender may make proof of loss if not made promptly by Borrower. Unless Lender and Borrower otherwise agree in writing, any insurance proceeds, whether or not the underlying insurance was required by Lender, shall be applied to restoration or repair of the Property, if the restoration or repair is economically feasible and Lender's security is not lessened. 11. Joint and Several Liability; Co-Grantor; Successors and Assigns Bound. Borrower covenants and agrees that Borrower's obligations and liability shall be joint and several. 12. Loan Charges. Lender may charge Borrower fees for services performed in connection with Borrower's default, for the purpose of protecting Lender's interesting the Property and rights under this Security Instrument, including, but not limited to, attorneys' fees, property inspection and valuation fees. In regard to any other fees, the absence of express authority in this Security Instrument to charge a specific fee to Borrower shall not be construed as a prohibition on the charging of such fee. Lender may not charge fees that are expressly prohibited by this Security Instrument or by Applicable Law.

If the Loan is subject to a law which sets n ax mum loan charges, and that law is finally interpreted so that the interest or other loan charges collected or to be collected in come it is n with the Loan exceed the permitted limits, then: (a) any such loan charge shall be reduced by the amount necessary to reduce to the permitted limit; and (b) any sums already collected from Borrower which exceeded permitted limits will be refunded to Borrower. Lender may choose to make this refund by reducing the principal owed under the Debt Instrument or by making a direct payment to Borrower.
