THIS INDENTURE WITNESSETH, That the Grantor GERALDINE DANIELSEN

of the County of COOK and State of ILLINOIS for and in consideration of TEN & NO/100 (\$10.00) Dollars, and other good and valuable considerations in hand paid, Conveys and warrant s unto the WESTERN NATIONAL BANK OF CICERO, a National Banking Association, as Trustee under the provisions of a trust agreement dated the 17th day of April 1975, known as Trust Number 5756 , the following described real estate in the County of Cook and State of Illinois, to-wit:
