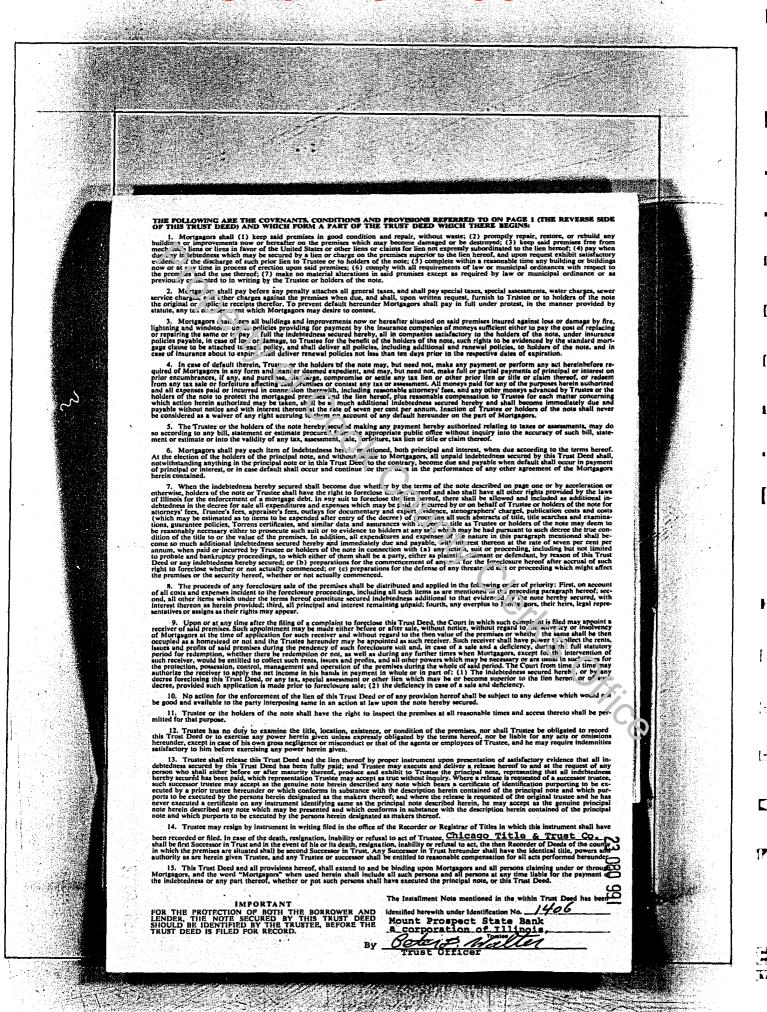

RIDER ATTACHED TO AND MADE A PART OF TRUST DEED DATED May 1, 1975 , between: Edward J. Nelson and Rose C. Nelson, his wife and Mount Prospect State Bank, a corporation of Illinois, Trustee.

The mortgagor agrees that in order to more fully protect the security of this mortgage, mortgagor shall deposit with the holder of the Note on the let day of each month, beginning on the lst day of July 19 75, one-twelfth (1/12) of the amount (as estimated by the holder of this mortgage) which will be sufficient to pay taxes, special assessments and other charges on the real estate that will become due and payable during the ensuing year.

The holder of the Note shall hold such monthly deposits in trust without any allowances of interest, and shall use such funds for the payment of such items when the same are due and payable.

If at any time the fund so held by the holder of the Note is insufficient to pay any such item when the same shall become due and payable, the holder of the Note in 11 advise the mortgagor of the deficiency, and mortgagor shall, within ten (10) days after receipt of such notic. Reposit with the holder of the Note such additional lunds as may be necessary to pay such items.

Failur. to meet any deposit when due shall be a breach of this roltgage.

If at any time there shall be a default in any of the provisions of this mortgage, the holder of the Note may, at its option, apply any money in the fund on any of the mortgage chligations and in such order and manner as it may slect.
