JUDGE'S DEED

WHEREAS, on the 7th day of February 2023 in Case Number 21 M6 8997 entitled THE CITY OF CHICAGO HEIGHTS V. AVIS BOLTON, INEZ HALEY, MILTON HALEY, UNKNOWN OWNERS and NON-RECORD CLAIMANTS, an ORDER DECLARING PROPERTY ABANDONED was entered which provided that the property located at 452 East 22nd Street, Chicago Heights, Illinois and legally described as follows:

NOW, THEREFORE, with all notifications being made, and with no party with an interest in the subject premises filing an appearance in this matter, or a request to demolish or repair the subject premises is made, know all men by these presents, that I, Judge CHRISTOPHER P.
