THE FOLLOWING ARE THE COVENANTS, CONDITIONS AND PROVISIONS REFERRED TO ON PAGE I (THE REVERSE SIDE OF THIS THEST DEED) AND WHICH FORM A PART OF THE TREST DEED WHICH THERE BEGINS

- 1. Mortgagors shall (1) keep said premises in good condition and repair, without waste, (2) promptly repair, restore, or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed, (3) keep said premises free from mechanic's tiens or tiens in favor of the United States or other lines or claims for the not expressly subordinated to the lien hereoff, (4) pay when due any indebtedness which may be secured by a lien or charge on the primises superior to the lien hereoff, and upon request exhibit satisfactory evidence of the discharge of such prior tien to Erustee or to holders of the note, (5) complete within a reasonable time any building or buildings now or at any time in process of erection upon said premises. (5) comply with all requirements of law or numerical ordinances with respect to the premises and the use thereof, (7) make no material alterations in said premises except as required by law or numerical ordinance or as previously consented to in writing by the Trustee or holders of the note.
- Mortgagors shall pay before any penalty attaches all general taxes, and shall pay special taxes, special assessments, water charges, sewer service charges, and other charges against the premises when due, and shall, upon written request, furnish to Trustee or to holders of the note the original or duplicate receipts therefor. To prevent default hereunder Mortgagors shall pay in full under protest, in the manner provided by statute, any tax or assessment which Mortgagors may desire to contest.
- 3. Mortgagors shall keep all buildings and improvements now or hereafter situated on said premises insured against loss or damage by fire, lightning and windstorm under policies providing for payment by the insurance companies of moneys sufficient either to pay the cost of replacing or repairing the same or to pay in full the indebtedness secured hereby, all in companies satisfactory to the holders of the note, under insurance policies payable, in case of loss or damage, to Trustee for the henefit of the holders of the note, such rights to be evidenced by the standard mortgage clause to be attached to each policy, and shall deliver all policies, including additional and renewal policies, to holders of the note, and in case of insurance about to expire, shall deliver renewal policies not less than ten days prior to the respective dates of expiration.
- 4. In case of default therein. Trustee or the holders of the note may, but need not, make any payment or perform any act hereinbefore required of Mortgagors in any form and manner deemed expedient, and may, but need not, make full or partial payments of principal or interest on prior encumbrances, if any, and purchase, discharge, compromise or settle any tax lien or other prior lien or title or claim thereof, or redeem from any tax sale or forfeiture affecting said premises or contest any tax or assessment. All moneys paid for any of the purposes herein authorized and all expenses paid or incurred in connection therewith, including reasonable attorneys fees, and any other moneys advanced by Trustee or the hold is to the note to protect the mortgaged premises and the lien hereof, plus reasonable compensation to Trustee for each matter concerning which also herein authorized may be taken, shall be so much additional indebtedness secured hereby and shall become immediately due and payable without notice and with interest thereon at the rate of seven per cent per annum. Inaction of Trustee or holders of the note shall never be considered as a waiver of any right accruing to them on account of any default hereunder on the part of Mortgagors.
- 5. The Thirtee or the holders of the note hereby secured making any payment hereby authorized relating to taxes or assessments, may do according to an bill, statement or estimate produced from the appropriate public office without inquiry into the accuracy of such bill, statement or estimate or into the validity of any tax, assessment, sale, forfeiture, tax lien or title or claim thereof.
- 6. Mortgago s. h.ill pay each item of indebtedness herein mentioned, both principal and interest, when due according to the terms hereof. At the election of the new lars of the principal note, and without notice to Mortgagors, all unpaid indebtedness secured by this Trust Deed shall, notwithstanding anything in the principal notice or in this Trust Deed to the contrary, become due and payable when default shall occur in payment of principal or interest, or in lase default shall occur and continue for three days in the performance of any other agreement of the Mortgagors
- 7. When the indebiedness hereby secured shall become due whether by the terms of the note described on page one or by acceleration or officewise, indices at the note of order of the note of the no
- 8 The proceeds of any foreclosure sale of the premises shall be distributed and applied in the following order of priority: First, on account of all costs and expenses incident to the foreclosure proceedings, as incing all such items as are mentioned in the preceding paragraph hereof; second, all other items which under the terms hereof constitute secund is debtedness additional to that evidenced by the note hereby secured, with interest therein provided; third, all principal and interest the aning unpaid; fourth, any overplus to Mortgagors, their heirs, legal representatives or assigns as their rights may appear.
- 9. Upon or at any time after the filing of a complaint to foreclose the Tri st Deed, the Court in which such complaint is filed may appoint a receiver of said premises. Such appointment may be made either before or after 8 c, without notice, without regard to the solvency or insolvency of Mortgagors at the time of application for such receiver and without regard 2 it to then value of the premises or whether the same shall be then occupied as a homestead or not and the Trustee hereinder may be appointed as such receiver. Where a release is requestee of a consort trustee, such successor trustee may accept as the genuine note herein described any note which bears a certificate of identification pt the line to be executed by a prior trustee hereinder or which conforms in substance with the description herein contained of the principal not- and which purports to be executed by the persons herein designated as the makers thereof; and where the release is requested of the original trustee and he has never executed a certificate on any instrument identifying same as the principal note described herein, he may accept as the genuine principal note herein described any note which may be presented and which conforms in substance with the description herein contained of the principal note and which purports to be executed by the persons herein designated as makers thereof.
- 14. Trustee may resign by instrument in writing filed in the office of the Recorder or Registrar of Titles in which this instrument shall have been recorded or filed. In case of the death, resignation, inability or refusal to act of Trustee, Maywood-Proviso State Bank shall be first Successor in Trust and in the event of his or its death, resignation, inability or refusal to act, the then Recorder of Deeds of the country in which the premises are situated shall be second Successor in Trust.
