THIS INDENTURE WITNESSETH, That the Grantor

Full power and authority is hereby granted in said trustee to subdivide and consolidate the real estate or any part thereof; to dedicate parks, streets, highways and alleys and to convey any subdivision or part thereof; to execute contracts in writing or otherwise and agreements to purchase, to execute contracts to sell on any terms, to convey either with or without consideration; to convey the real estate or any part thereof to a successor or successors in trust and to grant to such successor or successors in trust all the title, estates, powers and authorities vested in the trustee or in any part thereof, from time to time, in possession or reversion, by leases to commence in present or future, and upon any terms and for any period of time and to execute amendments to any lease or leases, to renew or extend any lease or leases, to renew or extend any period of time and to execute options to lease or to renew or extend any lease or leases, to renew or extend any period of time and to execute contracts respecting the manner of fixing the amount of present or future rentals, to execute grants of easements or changes of any kind, to release, convey or assign the real estate or any part thereof, to make any alterations, improvements, additions or other works on the real estate or any part thereof, to lease and every part thereof in all other ways and for such other considerations as it would be lawful for any person owning the title to the real estate to deal with it, whether similar to or different from the ways above specified and at any one or times hereafter.

If the title to any of the above lands is now or hereafter registered, the Registrar of Titles is hereby directed not to register or note in the certificate of title or duplicate thereof, or memorial, the words "in trust," or "upon condition," or "with limitation," or words of similar import, in accordance with the statute in such case made and provided.

And the said grantor hereby expressly waives \$ and releases \$ any and all right or benefit under and by virtue of any and all statutes of the State of Illinois, providing for the exemption of homesteads from sale on execution or otherwise.
