

## AFFIDAVIT OF HEIRSHIP


I, Brenda Bahena, on oath states as follows:

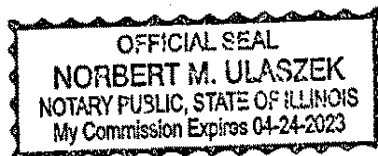
1. I currently reside at 1935 N. Kedzie Ave, Chicago, IL 60647.
