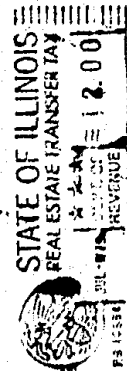
of the City of Hoffman Estates County of Cook and State of Illinois the following described Real Estate:

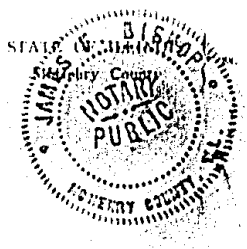
