The interest of each and every beneficiary hereunder and of elegersons claiming under them or any of them shall be only in the earnings, avails and proceeds arising it on the sale or other disposition of said real estate, and such interest is hereby declared to be personal property, and no beneficiary hereunder shall have any title or interest, legal or equitable, in or to said real estate as such, but only an interest in the earnings, avails and proceeds thereof as aforesaid.
