Contractor is entitled to credits of \$38,000.00 on account of payments made to Lien Claimant, leaving due unpaid and owing to Lien Claimant, after allowing all credits, the balance of \$50,366.55, for which, with interest, Lien Claimant claims a Mechanics Lien on said Premises and to monies or other considerations due or to become due from Owner under said contract between Contractor and Owner.
