 - B. I understand that the Loan Documents will not be modified unless and (ntil (i) the Lender accepts this Agreement by signing and returning a copy of it to me, and (ii) the Modification Effective Date (as defined in Section 3) has occurred. I further understand and agree that the Lender will not be obligated or bound to make any modification of the Loan Documents if I fail to meet any one of the requirements under this Agreement.
- The Modification. If my representations and covenants in Section 1 continue to be true in all
 material respects and all preconditions to the modification set forth in Section 2 have been
 met, the Loan Documents will automatically become modified on JULY 01, 2023 (the

"Modification Effective Date") and all unpaid late charges that remain unpaid will be waived. The first modified payment will be due on **JULY 01, 2023**.

- A. The Maturity Date will be: JUNE 01, 2063.
- B. The current Total Outstanding Balance of my loan includes all unpaid principal and amounts that will be past due as of the Modification Effective Date. The current Total Outstanding Balance of my Original Note includes unpaid principal, unpaid and deferred interest, projected escrow shortages, escrow advances and other costs, but excludes unpaid late charges, and is less any amounts paid to the Lender but not previously credited to my Loan. The current Total Outstanding Balance of my loan is \$227,559.88.
- C. The Total Outstanding Balance will be reduced by \$50,759.20. This amount will be included in a new, non-interest bearing Subordinate Note ("Subordinate Note"), payable to HUD, and will not be due until the Original Note is paid off, matures, or I sell the property, whichever is carliest.
- D. The Total Quistanding Balance less the amount of the Subordinate Note, or \$176,800.68, will be the New Principal Balance of my Original Note. Interest at the rate of 5.1250% will begin to accrue on the New Principal Balance as of JULY 01, 2023 and the first new monthly payment on the New Principal Balance will be due on JULY 01, 2023.

- G. That the mortgage insurance premiums on my loan may increase and the date on which I may request cancellation of mortgage insurance may change as a result of this loan modification.
- H. That, as of the Modification Effective Date, notwithstanding any other provision of the Luar Documents, if all or any part of the Property or any interest in it is sold or transferred without Lender's prior written consent, Lender may, at its option, require immediate paymerath full of all sums secured by the Security Instrument. Lender shall not exercise this option in state or federal law, rules or regulations prohibit the exercise of such option as of the date of such sale or transfer of Lender exercises this option, Lender shall give me notice of acceleration. - I. That, as of the Modification Elective Date, I understand that the Lender will only allow the transfer and assumption of the Loan including this Agreement, to a transferee of my property as permitted under the Garr St. Germain Act, 12 U.S.C. Section 1701j-3. A buyer or transferee of the Property will not be permitted, under any other circumstance, to assume the Loan. Except as noted herein, this Agreement may not be assigned to, or assumed by, a buyer or transferee of the Property.
- J. That, as of the Modification Effective Date, if any provision in the Original Note or in any addendum or amendment to the Original Note allowed for the assessment of a penalty for full or partial prepayment of the Original Note, such provision is null and void.
- K. That, I will cooperate fully with Lender in obtaining any title endersement(s), or similar title insurance product(s), and/or subordination agreement(s) that are necessary or required by the Lender's procedures to ensure that the modified mortgage Loan is in first lien position and/or is fully enforceable upon modification and that if, under any circumstance and not withstanding anything else to the contrary in this Agreement, the Lender does not receive such title endorsement(s), title insurance product(s) and/or subordination agreement(s), then the terms of this Agreement will not become effective on the Modification Effective Date and the Agreement will be null and void.
- L. That, if any foreclosure action against me is dismissed as a result of entering into this Agreement, I will remain liable for and bear my own attorney fees and costs incurred in connection with such action, if permitted by applicable law.
- M. That I will execute such other documents as may be reasonably necessary to either (i) consummate the terms and conditions of this Agreement; or (ii) correct the terms and

However, I acknowledge that Lender retains certain rights, including but not limited to the right to foreclose its lien evidenced by the Security Instrument under appropriate circumstances. The parties agree that the consideration for this Agreement is Lender's forbearance from presently exercising its rights and pursuing its remedies under the Security Instrument as a result of my original thereunder.
