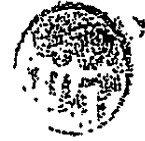

FINAL JUDGMENT

This matter, coming to be heard on the Third Party Citation to Discover Assets (the "Citation") issued to Pro Star Auto Group LLC ("PSAG") and this Court's February 23, 2023 Order (the "Rule to Show Cause") requiring PSAG to show cause why it should not be held in civil contempt of court for its failure to respond to the Citation and the April 3, 2023 Conditional Judgment entered in favor of Plaintiff and against PSAG (the "Conditional Judgment") and the April 5, 2023 Summons After Conditional Judgment to PSAG, all parties being duly noticed and the Court being fully advised in the premises,

IT IS HEREBY FOUND AND ORDERED THAT:

1. Pursuant to the validly issued and properly served Citation, PSAG was required to respond to the Citation by a date certain and/or appear in Court pursuant to the Citation.
2. PSAG failed to respond as required and/or appear in Court pursuant to the Citation and the Court entered the Rule to Show Cause.
3. PSAG failed to appear in Court as required by the Rule to Show Cause.
4. Accordingly, on April 3, 2023, the Court entered the Conditional Judgment against PSAG in the amount of \$164,663.63 as of December 12, 2019, plus post-judgment interest accruing thereafter (which is the amount remaining due and owing under the original judgment entered against the above-named defendants/judgment debtors).

5. Thereafter, on April 5, 2023, a Summons After Conditional Judgment was issued and served upon PSAG. The return date was May 22, 2023.

6. PSAG did not appear and/or take any other action with respect to the Conditional Judgment on or before May 22, 2023.

7. To date, PSAG has failed to appear in court or produce any documents in response to the Citation, Rule to Show Cause, Alias Rule and/or the Summons After Conditional Judgment.

IT IS THEREFORE ORDERED AND ADJUDGED BY THIS COURT AS FOLLOWS:

A. A FINAL Judgment is hereby entered in favor of Plaintiff Siemens Financial Services, Inc. and against PSAG in the amount of \$164,663.63 as of December 12, 2019, plus post-judgment interest accruing thereafter (which is the amount remaining due and owing under the original judgment entered against the above-named defendants/judgment debtors).
