#### ASSIGNMENT AND ASSUMPTION OF MEMBERSHIP INTERESTS

TAIS ASSIGNMENT AND ASSUMPTION OF MEMBERSHIP INTERESTS ("Assignment") is entered into as of the 17th day of June, 2022 (the "Effective Date"), by and among all of the undersigned Members of SKY RIVER, LLC, an Illinois limited liability company (collectively, "Assignor"), and SKY RIVER, LLC ("Assignee), through its authorized Member/Manager.

- 1. <u>Assignment</u>. Assignor hereby sells, assigns, transfers and conveys to Assignee the Membership Interest.
- 2. <u>Assumption</u>. Assignee hereby accepts from Assignor the Membership Interest, and assumes all of the obligations and liabilities of Assignor, at the holder of the Membership Interest, accruing from and after the date hereof.
- 3. <u>Withdrawal</u>. Assignor hereby withdraws as a member from the Company (the "Withdrawal"). The Withdrawal shall be effective as of the date hereof, without the need for execution of any additional documentation.
- 4. <u>Resignation</u>. If applicable, Assignor hereby resigns as a Manager of Company.
- 5. <u>Effective Date</u>. This Assignment is effective as of the date hereof, and from and after the date hereof that portion of the net profits or net losses and cash flow of the Company allocable to the Membership Interest shall be credited, charged or distributed, as the case may be, to Assignee and not to Assignor.

- 6. <u>Indemnification of Assignee</u>. The Assignor shall indemnify, defend and hold harmless Assignee, its agents, employees, officers, directors, managers, members, legal representatives, successors and assigns from and against any liability, loss, cost or expense (including but not limited to reasonable attorney's fees and expenses) incurred by Assignee as a result of such Assignor's failure to perform any of its obligations as holder of the Membership Interest to the extent that such obligations accrued prior to the date hereof.
- Indemnification of Assignor. Assignee shall indemnity, defend and hold harmless Assignor, its agents, employees, officers, directors, managers, members, legal representatives, successors and assigns from and against any liability, loss, cost or expense (including but not limited to reasonable attorney's fees and expenses) included by Assignor as a result of Assignee's failure to perform any of its obligations as holder of the Membership Interest to the extent that such-obligations accrue or or after the date hereof.
- Miscellaneous-This Assignment shall inure to the benefit of and be binding upon 8. the parties hereto-and their respective legal or personal representatives, heirs, executors, administrators, successors, and assigns. No third party skall have the benefit of any of the provisions of this Assignment nor is this Assignment made with the intent that any person contity other than Assignor or Assignee rely hereon. If Assignor or Assigned resorts to a court of law or equity in order to enforce the provisions of this Assignment as against the other, the non-prevailing party shall pay the reasonable attorneys' fees and expenses of the prevailing party.
