That, based on my review of available records, including, where applicable, the chain of endorsements on the Note, securitization documents, the collateral file, or other records of the loan, this loan was indeed assigned from PROSPECT MORTGAGE, LLC to LAKEVIEW LOAN SERVICING, LLC, and as such, an assignment should have been executed and recorded to indicate same. 8. That, after a diligent good faith attempt, I have concluded such assignment(s) cannot now be obtained. If a copy of one or more
