#### RELEASE OF REDEVELOPMENT AGREEMENT

THIS RELEASE OF REDEVELOPMENT AGREEMENT is executed on or as of the 24 day of \_\_\_\_\_\_\_, 2023, by the CITY OF CHICAGO, as filinois municipal corporation, acting by and through its Department of Housing (the "City").

Spathies Construction Corporation, an Illinois corporation (the "Developer"), and the City entered into that certain Redevelopment Agreement – City Lots for City Living (the "Agreement"), dated as of April 19, 2005, and recorded with the County Clerk of Cook County on September 22, 2005, as document number 0526545126. The Agreement encumbered several parcels of land, including the property legally described on <a href="Exhibit A">Exhibit A</a> attached hereto and made a parchereof (such property legally described in <a href="Exhibit A">Exhibit A</a>, the "Property"). The City has not conveyed, is not obligated to convey, and does not intend to convey, the Property to the Developer.

In order to clear the title to the Property, the City now desires to release and does hereby release the Agreement from the Property and the Agreement shall be of no further force and effect with respect to the Property.
