**JUDGMENT**

This cause coming to be heard on Plaintiff, The Cadle Company's ("Cadle") Motion for Summary Judgment (the "Motion") against Defendant Johnny Lockett ("Lockett"), due notice having been given, counsel for Cadle, counsel for Lockett and Lockett appearing, no response was filed, the Court being fully advised in the premises, it is hereby ORDERED:

1. Cadle's Motion is GRANTED.
2. Judgment is entered in favor of Cadle and against Lockett in the amount of \$98,766.24, which amount is comprised of principal in the amount of \$74,221.22, pre-judgment interest in the amount of \$9,554.63 through January 25, 2023, at the variable rate of Prime plus .25 with a current per diem rate of \$15.98, late fees in the amount of \$2,641.25, other fees in the amount of \$0.00; reasonable attorneys' fees in the amount of \$5,625.00 through January 23, 2023, and reasonable costs in the amount of \$569.57, plus interest accrued from January 26, 2023 through today's date of \$1,879.57 (variable interest with a current per diem of \$17.52) and additional reasonable attorneys' fees in the amount of \$4,275.00. This amount shall continue to accrue post-judgment interest at the statutory rate, from the date of entry of the judgment until the judgment, including all accrued interest, has been paid in full.

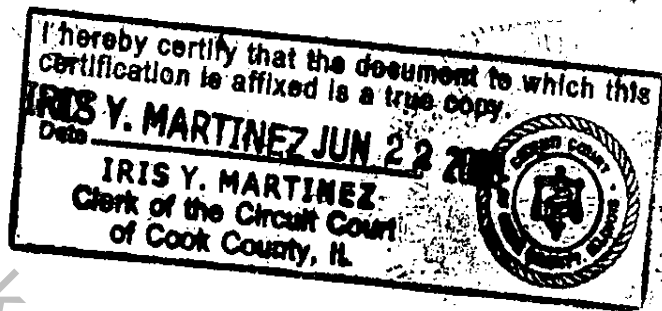
