THIS INDENTURE WITNESSETH, That the Grantor,  
a/k/a/ John Lynch, a bachelor,

of the County of Cook and State of ILLINOIS, for and in consideration  
of the sum of ten Dollars (\$ 10.00),  
in hand paid, and of other good and valuable considerations, receipt of which is hereby duly acknowledged, Convey  
and Warrant unto THE COSMOPOLITAN NATIONAL BANK OF CHICAGO, a corporation duly organized  
and existing as a national banking association under the laws of the United States of America, and duly authorized  
to accept and execute trusts within the State of Illinois, as Trustee under the provisions of a certain Trust Agree  
ment, dated the 7 day of March 1968, and known as Trust Number 17618  
the following described real estate in the County of Cook and State of Illinois, to-wit:

Lot 18 in Block 5 in Library Subdivision of that part  
of the South East 1/4 of the North East 1/4 of Section  
8, Township 38 North, Range 14, East of the Third  
Principal Meridian, lying south of the right of way of  
Grand Trunk Railroad according to the plat thereof  
recorded in Book 25 of Plats Page 31, known as 852847

1974 and 1975 real estate taxes.

In no case shall any party dealing with said Trustee, or any successor in trust, in relation to said real estate, or to whom said real estate may be sold, be entitled to any information concerning the title to said real estate, or to the application of any purchase money, rent or money borrowed or advanced on said real estate, or be obliged to see that the terms of this trust have been complied with, or be obliged to inquire into the authority, necessity or exceedance of any act of said Trustee, or be obliged or required to accept any conveyance or assignment of title made by said Trustee, or any successor in trust, in relation to said real estate, shall be conclusive evidence in favor of every person (including the Registrar of Titles and county) relying upon or claiming under such conveyance or lease of said instrument, (a) that at the time of the execution of the trust instrument, there was no conflict between the terms of this instrument and the terms of the Trust Agreement, (b) that this instrument was executed in accordance with the trusts, conditions and limitations contained in this Indenture, and in said Trust Agreement or in any amendment thereto, and (c) that all beneficiaries hereinunder, (d) that said Trustee, or any successor in trust, is duly authorized to execute and bind upon all beneficiaries hereinunder, (e) that such successor or successors in trust have been properly appointed, and are fully vested with all

This instrument is made upon the express understanding and condition that neither The Comptroller National Bank of Chicago, individually or as trustee, nor any of its officers, agents or attorneys shall be liable for anything it or they or its or their agents or attorneys may do or omit to do in or about the said real estate under the provisions of this instrument, and that the said Comptroller National Bank of Chicago, individually or as trustee, and all such liability being hereby expressly waived and released. Any contract, obligation or liability incurred by the Comptroller National Bank of Chicago, individually or as trustee, in connection with said real estate may be entered into by it in the name of the then beneficiaries under said Trust. As far as at their attorney, agent or trustee, the Comptroller National Bank of Chicago, individually or as trustee, except that so far as the trust property and funds in the actual possession of the Trustee shall be applicable for the payment and discharge thereof. All costs and expenses of recording this instrument shall be borne by the Comptroller National Bank of Chicago.

The interest of each and every beneficiary hereunder and under said Trust Agreement, and of all persons claiming under them or any of them shall be only in the earnings, avails, and proceeds arising from the sale of any other disposition of said real estate, as such interest or claim may be held by the beneficiaries and their heirs, executors, administrators, and personal representatives, hereinafter referred to as such, but not an interest in the earnings, avails and proceeds thereof, the intention hereof being to have it in said The Committee to hold the title to any of the above real estate in the name of the Committee, and to all of the real estate above described.

If the title to any of the above real estate is now or hereafter registered, the trustee of the Trust, or his or her assigns, shall record the certificate of title or duplicate thereof, or memorial, the words "in trust," or "upon condition," or "with limitations," or words of similar import, or any other words which will indicate that the title is held in trust, or otherwise, or will be deemed to produce the effect of a trust, or a copy thereof, or any extracts therefrom, as evidence that any transfer, charge or other dealing involving the registered land is in accordance with the true intent and meaning of the Trust.

Section 11. Any and all right to benefit under and by virtue of any and all statutes of the State of Illinois, providing for the exemption of homesteads from sale on execution or otherwise.
