December 21, 1964 and known as Trust No. 21073, recorded in the Office of the Recircle of Deeds of Cook County, Illinois as Document No. 22831375, as amended from Jue to time, together with the percentage(s) of the Common Elements appurtenant to said Unit(s) as set forth in said Condominium Declaration,
