WITNESSETH, that said party of the first part, in consideration of the sum of Ten (\$10.00) and no/100ths dollars, and other good and valuable considerations in hand paid, does hereby Quit Claim and convey unto said parties of the second part, *not as tenants in common but as joint tenants*, the following described real estate, situated in Cook County, Illinois, to-wit:

Lot 17 in Lathrop and Larned's Subdivision of part of the South East quarter of the South East quarter of Section 6, Township 38 North, Range 14, East of the Third Principal Meridian in Cook County, Illinois

Together with the tenements and appurtenances thereto belonging,
TO HAVE AND TO HOLD the same unto said parties of the second part, *not as tenants in common but as joint tenants*, and to the proper use, benefit and behoof forever of said party of the second part.

This deed is executed by the party of the first part, as Trustee, pursuant to and in the exercise of the power and authority granted to him by the terms of said Deed in Trust and the provisions of said Trust Agreement above mentioned, and of every other power and authority thereto pertaining, given to him by the terms of all trust agreements, mortgages and deeds of record in said county; all unpaid general taxes and assessments, and claims of any kind, pending litigation, if any, affecting this said real estate, building, lines, fixtures, and all other restrictions of record; if any; acts of the party wall rights and any other agreement if any; zoning, building, and other ordinances, mechanics lien claims, if any; and rights or claims of any kind, if any.
