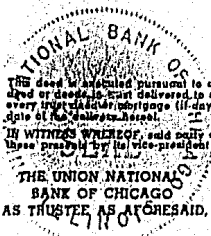

WITNESSETH, that said party of the first part, in consideration of the sum of TEN AND NO/100ths _____ dollars, and other good and valuable considerations in hand paid, does hereby grant, sell and convey unto said parties of the second part, not as tenants in common, but as joint tenants, the following described real estate, situated in Cook County, Illinois, to-wit: Lot 15 (except the North 7.425 feet thereof), all of Lot 16, and Lot 17 (except the South 8.128 feet thereof) all in Block 2 in Whitney and Bishop's Addition to Tinley Park, plat of the Southeast quarter of the Northeast quarter of Section 31, Township 36 North, Range 13, East of the Third Principal Meridian, Town of Bremen, Cook County, Illinois, recorded December 26, 1890 as Document 1393683; ALSO: That part of the East 1/2 of the heretofore vacated 14-foot wide North and South public alley as heretofore dedicated in Block 2 in the aforesaid subdivision, lying South of the Westerly prolongation of the South line of the North 7.425 feet of said Lot 15 and lying North of the Westerly prolongation of the North line of the South 8.128 feet of said Lot 17, all in Cook County, Illinois.

Together with the tenements and appurtenances thereto, hereunto TO HAVE AND TO HOLD the same unto said parties of the second part forever, not in tenancy in common, but in joint tenancy.
