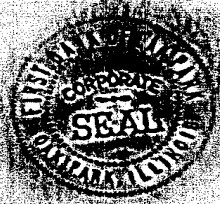
together with the tenements and appurtenances thereunto belonging. *To Have and to Hold* the same unto said party of the second part or her **as joint tenants and not as tenants in common.**

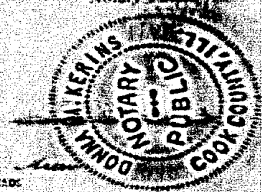
