EXHIBIT A

LEGAL DESCRIPTION

Parcel 1:

The East 1/2 of Lot 12 and all of Lots 13, 14, 15 and 16 (except the South part of said Lots falling in alley and except the East 20 feet of Lot 16 falling in street), together with the South 1/2 of vacated Grenshaw Street lying North of and adjoining said Land in Erl Reynolds and George W. Merrill's Subdivision of Block 36 in School Section Addition to Chicago in Section 16, Township 39 North, Range 14, East of the Third Principal Meridian, in Cook County, Illinois.

Parcel 2:

A parcel of Land comprising parts of Lots 10, 11 and 12 and a part of vacated West Grenshaw Street in Erl Reynolds and G. W. Merrill's Subdivision of Block 36 in School Addition all in Section 16, Township 39 North, Range 14, East of the Third Principal Meridian, bounded and described as follows:
