TRUST DEED AND NOTE

THIS INDENTURE WITNESSETH, That the undersigned as grantors, of _____, and State of Illinois, for and in consideration of the sum of One Dollar and other good and valuable considerations, in hand paid, convey and warrant to Harris Trust & Savings Bank of Chicago, County of Cook and State of Illinois, the following described Real Estate, with all improvements thereon, situated in the County of Cook, in the State of Illinois, to wit: Lot 14334 in Section 1 Weathersfield Unit 14, being a subdivision in the North $\frac{1}{4}$ of Section 28 Township 41 North Range 10 East of the third principal meridian in Cook County, Ill.

GRANTORS AGREE to pay all taxes and assessments upon said property when due, to keep the buildings thereon insured to their full insurable value, to pay all prior liens and the interest thereon and to keep the property tenable and in good repair and free of taint, thereafter, which shall with $\frac{1}{2}\%$ interest thereon, become due immediately, without demand. On default in any payments hereunder, grantee may declare the whole indebtedness due and proceed accordingly.

AS FURTHER RECDATORS grantors hereby assign, transfer and set over to grantee all the rents, issues and profits of said premises, from and after this date, and authorize him to sue for, collect and receipt for the same, to serve all necessary actions and demands, to bring forcible detainer proceedings to recover possession thereof, to repossess the said premises as he may deem proper and to apply the money so arising to the payment of this indebtedness, or to any advancements made as aforesaid, and it shall not be the duty of grantor to inquire into the validity of any such taxes, assessments, liens, encumbrances, interest or advancements.

In trust, nevertheless, for the purpose of securing performance of the following obligation, to-wit:

14,235.00 after date for value received I (we) promise to pay to the order of Harris Trust and ¹⁰⁰ ₁₀₀

Savings Bank the sum of Fourteen thousand two hundred thirty five and 00/100 at the office of the legal holder of this instrument with interest at 6 per cent. per annum after date hereof until paid. And to whom the payment of said amount (if I (we) by attorney, irrevocably any attorney or any agent of record in any County or State in the United States to whom we in such court, in term time or vacation, at any time hereafter and whenever a judgment without process in favor of the holder of this instrument for such amount as may appear to be unpaid thereon, together with costs, and Twenty-Five Dollars Attorney's fees, and to waive and release all errors which may appear to be in any such proceeding, and request to immediate execution upon such judgment, hereby ratifying and confirming all that my (our) said attorney may do by virtue hereof.

IN THE EVENT of the death, inability, removal or absence from said Cook County of the Trustee, or of his refusal or failure to act, then Harris Trust & Savings Bank of and County, is hereby appointed to be the first successor in this trust; and if for any like cause first successor fail or refuse to act, the person who shall then be the acting Receiver of Funds of said County is hereby appointed to be second successor in this trust. And where all the aforesaid covenants and agreements are performed by the trustee, or his successor in trust, shall release the premises to the party entitled thereto on receiving his reasonable charge.
