TO HAVE AND TO HOLD the same unto said party of the second part, and to the proper use, benefit and behoof, forever, of said party of the second part

Subject to general real estate taxes for the years 1974 (first installment of which has been paid) and 1975 and subsequent years; conditions, easements, restrictions or records.

This deed is executed by the party of the first part, as Trustee, as aforesaid, pursuant to and in the exercise of the power and authority granted to and vested in it by the terms of said Deed in Trust and the provisions of said Trust Agreement, above mentioned, and of every other power and authority thereunto enabling, SUBJECT, HOWEVER, to, the title of all trust deeds and mortgages upon said real estate, if any, of record in said County, all unpaid general taxes and special assessments and other taxes or debts of any kind, pending litigation, if any, affecting said real estate, building lines, building, liquor and other restrictions of record, if any, survey walls, party wall rights and other rights and obligations, zoning and Building Laws and Ordinances, Mechanics' Lien claims, if any, attachments of record, if any, and rights and interests of parties in possession.
