(c) Application of Miscellaneous Proceeds upon Condemnation, Destruction, or Loss in Value of the Property. 17. Governing Law; Severability; Rules of Construction. This Security Instrument is governed by federal law and the law of the State of Illinois. All rights and obligations contained in this Security Instrument are subject to any requirements and limitations of Applicable Law.
